Mykotoxine (Schimmelpilzgifte) sind Stoffwechselprodukte der Schimmelpilze, die bei Wirbeltieren – zu denen auch die Amphibien gehören – bereits in geringsten Mengen Vergiftungserscheinungen hervorrufen. Die Erkrankung durch Mykotoxine heißt **Mykotoxikose**.

Mycotoxins (mold toxins) are metabolites of molds that in vertebrates - which also include the amphibians - cause poisoning symptoms even in very small quantities. The disease caused by mycotoxins is called **mycotoxicosis**.
